We are guided by previous resolutions and statements of the *International Treasury Monetary One*,

We hereby declare that jointly: White Spiritual Boy R.S.B. 

any way. Based on the foregoing, as a result of a long and deep joint work: investigations, checks, re-checks, work and conclusions of specially created commissions, the *International Treasury Monetary One* came to the following:

3.1) To find and confiscate all their property from world criminals deprived of legal personality and outlawed by this Resolution, with further transfer to the *International Treasury Monetary One*, with subsequent distribution to the international social programs in favor of the poor.

4) To all International and Country Law Enforcement Organizations, all International and Country Counter-Terrorism Organizations, all State and private military organizations, all International and country control and monitoring organizations, to block and confiscate all the assets formed on a criminal basis with further transfer to the International Treasury Monetary, with subsequent distribution to the international social programs in favor of the poor.
