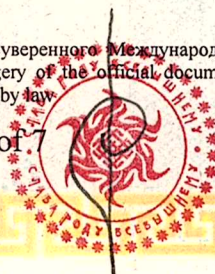
Fulfilling the Sacred Mission to fulfill God's Providence and Great Providence,
